
#### WHAT WILL BE HAPPENING ON SITE IN THE NEAR FUTURE?

John F Hunt will be installing new sections of hoarding, demolishing all existing buildings and remediating the ground. The main construction works will be delivered by a separate contractor. John F Hunt are now in possession of all plots and will very shortly start undertaking on-site activities.

The first of these will be to start demolition works around the beginning of May. We anticipate their programme finishing on a plot by plot basis from November to January and as they do the main works contractor will follow-on, initially with their piling (foundation) works.

There is an opportunity for the community to get involved in a hoarding project. Working closely with our affordable workspace partners Bow Arts, we would like to invite artists, locals or other stakeholders to collaborate on artwork for our hoarding.

# ABOUT THE SCHEME..

We will be delivering 190 homes 100% affordable tenures split across London Affordable Rent and Shared Ownership. The development will include 4,131sqm of non-residential space including affordable workspace, light industrial space, studio offices, a community led incubator space, and some town centre retail.

We have partnered with Bow Arts who will be helping us deliver our commitments under the agreed workspace and public art strategy. There will also be more than 4,000sqm of new, high quality public space plus further residential play areas, roof terraces and podiums.
